Chair Barbara Fiala called the meeting to order at 4:06 p.m.

#### 1.0 INFORMATION ITEMS

#### 1.1 President's Report – Dr. Tony D. Hawkins

Dr. Hawkins reported that April is Community College Month and noted the College's plans to celebrate the occasion through social media. He attended the AACC Annual Conference and served as a panelist for the "New CEO" presentation. At the state level, the Legislature is expected to pass a resolution recognizing Community College Month, and advocacy efforts continue as the College awaits final approval of the state budget. Recent campus events included Open House and Alumni Weekend, which featured a celebration of the 60th anniversary of the Radiologic Technology program with tours, demonstrations, and a reception. Dr. Hawkins also participated in the Men of Color Summit at Binghamton University, with the Student Affairs Division providing transportation for SUNY Broome students to participate. The college also hosted its annual Guidance Counselor Breakfast for local school counselors. Upcoming events include the American Heart Association Walk, PTK All-New York Academic Awards Ceremony, Chancellor's Award for Student Excellence Award Ceremony, Annual Foundation Scholarship Reception, Mock Wedding, Retirement and Awards Dinner, and Commencement.

## 1.2 Faculty Senate Report- Dr. Andrew Haggerty

Dr. Haggerty submitted the Faculty Senate report in advance; it is included in the meeting packet. Although he could not attend the meeting, he expressed his appreciation to the Board of Trustees for their support of the Shared Governance restructuring efforts.

## 1.3 Student Affairs Report- Dr. Carol Ross-Scott

Dr. Ross-Scott reported that the Phi Theta Kappa induction ceremony took place the previous evening, with a notable increase in participation. This year's cohort includes 105 new inductees, reflecting growth compared to prior years. She submitted a report highlighting student engagement across departments within the division, demonstrating the impact of co-curricular activities on academic success. She highlighted students Amauri Truax and Alexandra Boullon, who were recognized for their achievements and involvement. Additionally, Dr. Ross-Scott shared that in Fall 2024, twenty-one student-athletes earned a GPA of 3.5 or higher.

## 1.4 Student Assembly Update – Sasha Asinovsky

Mr. Asinovsky reported that he has been meeting with College officials to learn more about campus operations and governance. He also announced his intention to run for the Student Trustee position for the 2025–2026 academic year. Student Assembly is currently collaborating with College departments to plan a Student Services Fair. Assembly members will be attending the upcoming SUNY Student Assembly (SUNY SA) conference, which will focus on student advocacy. Several new student clubs and organizations have been established this month, and committee meetings are ongoing. Mr. Asinovsky commended Dining Services for effectively accommodating students with dietary needs. He also noted strong student participation at recent campus events, including Free Skate and The Hive Mind.

# 1.5 **BCC Foundation Report – Cathy Williams**

Ms. Williams submitted the Finance and Development report, which was included in the meeting packet. As of the end of February 2025, the Foundation's total investment portfolio stood at \$45.1 million, with \$44.4 million designated as endowed funds. The Foundation's total assets were reported at \$50.8 million, including the beneficial interest in perpetual trusts. This reflects an increase from \$49.2 million in total assets at the close of the previous fiscal year on June 30, 2024. Alumni Reunion Weekend was held on April 11–12 in conjunction with the College's Open House. The Alumni and Faculty Mixer on April 11 was well attended. On April 12, the 60th anniversary of the Radiologic Technology program was celebrated, recognizing program Chairpersons Nancy Button and Colleen Donahue, as well as faculty member Barbara Valentino for their contributions. During the weekend, Lori Brewer conducted tours of the Hornet Hope Center. Prospective donors who attended expressed strong interest and were impressed by the range of services provided. Ms. Williams also reported that Continuing Student Scholarships have been awarded, and the application deadline for new student scholarships has been extended to May 8.

#### 1.6 **Budget and Finance Update – Michael Sullivan**

Mr. Sullivan reported that all financial activity for April 2025 remains consistent with expectations and reflects standard operating trends. As of March, the College continues to project a balanced budget without the need to draw on the \$956,000 in unrestricted fund balance that was included in the current year's budget. He also noted that the College is achieving strong interest earnings on its investments, generating approximately \$223,000 based on an average interest rate of 4%.
